ORDER

THIS CAUSE COMES BEFORE THIS HONORABLE COURT on a Petition for Injunctive Relief and Temporary Restraining Order filed by Plaintiff, RANDALL HENNIGAN, on June 3, 2021, and a Motion to Dissolve Temporary Restraining Order and Dilatory Exception of Prematurity filed June 8 and June 15, 2021, respectively, by Defendant, NATCHITOCHES PARISH SCHOOL BOARD. The hearing on all matters was heard on June 16, 2021, with the following persons present: Connor C. Headrick and R. Morgan Briggs representing Plaintiff, RANDALL HENNIGAN; and Robert L. Hammonds and Joe Stamey representing Defendant, NATCHITOCHES PARISH SCHOOL BOARD. After closing arguments, the court ruled from the bench.

AFTER CAREFUL CONSIDERATION OF THE LAW, EVIDENCE, EXHIBITS, PLEADINGS, AND ORAL AND WRITTEN ARGUMENTS OF LEARNED COUNSEL, AND FOR THE ORAL REASONS FOR JUDGMENT MADE THIS DATE IN OPEN COURT, IT IS ORDERED, ADJUDGED, AND DECREED THAT:

1. Defendant's Dilatory Exception of Prematurity be and is hereby is **GRANTED**;
2. The temporary restraining order now in effect be and is hereby **DISSOLVED FORTHWITH**, and
3. Plaintiff's Petition for Injunctive Relief and Temporary Restraining Order Preliminary Injunction is **DISMISSED** subject to the condition that the plaintiff may re-file his request for preliminary injunction if circumstances change.

IT IS FURTHER ORDERED that this court need not address the merits of Defendant's Motion to Dissolve Temporary Restraining Order and Plaintiff's Petition for Preliminary Injunction given the ruling on the Dilatory Exception of Prematurity, therefore judgment thereon is pretermitted.


IT IS FURTHER ORDERED that all court costs and Defendant's reasonable attorney's fees are cast to Plaintiff and shall be paid by the security posted by the Plaintiff with the Clerk of Court in accordance with La.Code Civ.P. art. 3610. Attorney's fees are set at the nominal sum of FIVE HUNDRED DOLLARS (US \$500); and

IT IS FURTHER ORDERED that Plaintiff is cast with costs for publication of the Natchitoches Parish School Board meeting scheduled to replace the cancelled June 3, 2021 meeting; and

IT IS FURTHER ORDERED that the Clerk of Court notify the parties of the signing of this Order.
