Rules Governing the Salary Policy

- 1) Implementation of this Salary Schedule will be effective July 1, 2024 and will be based on employees' qualifying years' experience.
- 2) Salary step advancement will be made on July 1st of each fiscal year. Individuals will be given credit for a year's advancement if they have served for at least one-half of the normal employment year.
- 3) Any certified teacher being promoted will automatically have the appropriate multiplier applied to their base at the time of assuming their new duties.
- 4) Certificated management employees in positions requiring a teacher's certificate will be eligible for sabbatical leave. They shall enjoy all the privileges, which they would have enjoyed had they been in active service, except that they shall not earn annual leave during the period of sabbatical leave.
- 5) Certificated management employees in positions requiring a teacher's certificate will be subject to the tenure policies of the Board and tenure laws of the State.
- 6) Only the Board shall have the right to change the pay range assignments of positions. All potential reassignments will be submitted by the Superintendent for review and recommendation.
 - a. All new positions shall be reviewed for initial pay range assignments as they are created.
 - b. The Superintendent shall have the right to request reassignments. He/She shall consider changing responsibilities and other factors pertinent to the position.
- 7) Persons requesting reassignment to a lesser position will immediately be placed in their new pay range with appropriate multiplier applied and at the same step they are currently assigned.
- 8) Newly certified teachers that have never worked in any district before may ask for a 13th check which will allow them to receive a payroll check at the end of August of their first academic year only. This option is only available in their first year of employment and must be requested through Human Resources via email.
- 9) When using administrative multipliers to calculate pay including estimated Sales Tax, please note that Sales Tax monies paid out to any administrator cannot exceed the amount paid to the highest paid active teacher.
- 10) Employees may request a review of their previous work experience of the Experience Review Committee to set their salary steps at a higher amount. These requests must be initiated by the employee wishing the review of starting steps and the forms are found in documents on the School Board website.
- 11) Experience Review Committee is comprised of the Director of Human Resources, Director of Business Affairs, and the Director or Supervisor of the department the employee is working under.

- 12) For certified personnel, the salaries reflected in the present salary schedule shall serve as full compensation for all work performed which relates to the duties and responsibilities set forth in such employees' job description. Any approved work performed by such employees which does not relate to the job duties and responsibilities specified in such employees' job descriptions shall be paid in accordance with La. R.S. 17:418 and shall be submitted to NPSB Payroll Department, along with the completed authorization form, within 10 calendar days from the date such work was performed.
- 13) Any teacher who is not afforded the minimum uninterrupted planning time required by R.S. 17:434(A) shall be compensated at the effective hourly rate of that teacher for each hour of planning time. A teacher's effective hourly rate, for the purposes of this payment, shall be calculated by converting the teacher's annual salary on the teacher's salary schedule adopted by the governing authority into an hourly rate of pay. Any additional, approved work performed by non-exempt personnel shall be paid in accordance with the Fair Labor Standards Act.

- 15) Any work performed by an employee beyond that in the employee's job description must be approved by the employee's immediate supervisor in advance by obtaining his/her signature on this completed document and:
- a. Should the amount of time required to complete the task exceed the estimated time provided by the employee, supervisor approval must be obtained before any additional time may be worked;
 - b. All documents required to obtain payment for such work must be submitted to NPSB Payroll Department within seven (10) workdays of the completion of the work for which additional compensation is sought; and
 - c. Should a teacher fail to receive the mandatory planning time during a week, the teacher must complete the applicable portion of this form and return it to his/her principal no later than the close of school the following Monday.

- This pay schedule also applies to Certified School Counselors, School Psychologist, Social Workers, Speech Therapists, Educational Diagnosticians, Occupational/Physical Therapist, Persons having a valid Practitioners License, and Special Ed. Coordinators/Facilitators.
- Personnel on a TAT (Temporary Authorization to Teach) will be paid from the Instructional Facilitator salary schedule on Page 8
- Additional supplemental pay, if needed, shall be calculated by converting the teacher's annual salary into an hourly rate of pay but shall not be less than \$30/hour

TAP Performance Pay Supplements

- TAP performance Supplements – Supplements to the base salary shall be paid to certificated school personnel that qualify for the performance-based compensations. Such supplement shall not be paid in any year in which the employee’s performance is rated “ineffective” and shall not be considered part of the employee’s base salary.
- Earned and paid in addition to base salary as a stipend payment once a year.
- The amounts vary based on teacher performance.
- The per teacher amount that is available in the performance pay pool is \$3000 for the 2024-2025 school year.
- To be eligible for performance-based compensation supplements, an employee cannot be absent more than 59 days per school year (excluding business and/or professional development). If an employee is not employed on the first or last day of their contract, the number of days they miss at the beginning or end of the year is included in the 59 days.
- All certified teachers, for TAP performance-based compensation, are eligible for performance-based compensation supplements based upon the percentages and categories shown below:
 - Teacher Instructional Growth:
 - 50% - Professional Practice Scores that utilizes Skills, Knowledge, and Responsibilities (based on the NIET Teaching Learning Standards Rubric)
 - Student Achievement Growth:
 - 30% - Classroom level Achievement Growth that utilizes Student Growth Scores (the minimum

classroom level student growth score that qualifies an individual for this portion is a student achievement growth core of 2)

20% - School-level Achievement Growth that utilizes a value-added model (the minimum school-wide value-added score that qualifies an individual to for this portion is a school-wide value-added score of 2.

- Performance Supplements are distributed in the school year that follows the final evaluation results from the prior fiscal year. Such supplements shall be considered as earned in the fiscal year when they are paid. Employee and employer contributions will be withheld on the Performance Supplements and/or transmitted to the various retirement systems.
- In order to receive a performance-based supplement all teachers must receive a completed satisfactory evaluation from the previous school year and meet attendance requirements.
- Supplements cannot be paid until the eligibility has been certified by the Superintendent and/or State.
- Substitute teachers, principals, assistant principals, administrative assistants, directors, supervisors, specialists, coordinators, appraisal team workers, and support employees are not eligible for Teacher Performance Supplements.
- School level administrators also receive performance supplements based on a weighted formula that allocates a factor to each of these areas: School-Wide Achievement Score, School Leader Observation Score, TAP Program Review Score.
