TO THE HONORABLE, THE JUDGES OF TENTH JUDICIAL DISTRICT COURT,
SITTING IN AND FOR THE PARISH OF NATCHITOCHE, STATE OF LOUISIANA.

NOW INTO COURT, through undersigned counsel, comes **RICKIE DALE THOMAS** and **ANNETTE THOMAS**, hereinafter referred to as "petitioner", whether one or more, who respectfully represents that:

1.

Petitioners shows that they obtained a Judgment on October 28, 2024 in the Parish of Avoyelles, 12th Judicial District Court, in the matter entitled **RICKIE DALE THOMAS, ET UX** Versus **RODRICK MCINTOSH** bearing docket #2024-1883-B in the amount of \$27,500.00, plus reasonable attorney fees in the amount of \$5,000.00 together with legal interest and all court costs. 3. That **RHODES REALTY, LLC**, be made garnishee, served with the Ex Parte Judgment and Garnishment Interrogatories and be ordered to answer, under oath, and after due legal proceedings, be ordered to deduct from the funds, assets or property, a portion or portions sufficient to satisfy petitioners judgment, plus all costs, all in accordance with law;
4. For all general and equitable relief to which petitioners are entitled.
